OVERVIEW: MODERNIZING GOVERNMENT TECHNOLOGY (MGT)

In 2008, David E. Garnett showcased the MOLIS database, designed to enhance capacity and encapsulate the diverse capabilities of HBCUs, Minority-Serving Institutions, and Tribal Colleges.

Following the demonstration, he spearheaded efforts to provide services through an 8A company. Concurrently, there were productive outreach and in-reach sessions with Southern University. Regrettably, the contract faced challenges with the 8A firm, prompting David to shift towards a strategy centered on revealing "The Greatest Stories Never Told" –an epitome of HBCU capacity building.

Moreover, the MGT strategy eagerly awaits the finalization of a \$700 million contract at HUD. Additionally, the already secured \$1B CHIP manufacturing project allowed us to mobilize a consortium of HBCUs for collaborative research, marking the commencement of further endeavors.
